### Article 3 Rights and Obligations of The Parties

### THE PARTIES:

The parties have to plan, organize, report, and evaluate the activities as a form of joint responsibility of both parties and report them to each university as evidence of the implementation of the events.

- a. The planning of the event involves: Making the event schedule; coordinating meetings; determining the contestants and team's supervisor; the event team and internal committee from both of the parties; and the financing scheme.
- b. The organizing of the event contains monitoring and coordination during the event implementation.
- c. The reporting of the event contains: making the report in 1 (one) month after the event is carried out (by the duties of each party), and reporting it to each university.
- d. The evaluation of the event involves evaluation meetings and making evaluation documents of the event activities.

### Article 4 Financing

- The cost of this event is covered by RKAT of Faculty of Humanities, Universitas Darussalam Gontor, and Prince of Songkla University.
- The three contestants and the team's supervisor will be provided with shared accommodation for four nights, three meals with refreshments, and local transportation during the events.

### Article 5 Addendum

- Any additions/changes to this Agreement have to be made with the consent of each party.
- 2. If one of the Parties wants to make any addition/change in this Agreement, then the Party has to tell the other Party by a written document.
- The additions/changes referred to in number (1) of this Article after agreed by THE PARTIES shall be outlined in an Addendum which becomes an inseparable part of this Agreement.

### Article 6 Dispute Resolution

If there is a dispute between THE PARTIES that relates to the implementation of the agreement in this activity, then THE PARTIES agree to resolve the dispute in deliberation.

### Article 7 Period

The implementation period of the agreement in this activity is set from the date of this event to the completion of the evaluation reporting on the implementation of this activity, namely on the date of May 2024 – June 2024.
