This Memorandum of Understanding (hereinafter referred to as MoU) is made on this **November 6th, 2024.**

BETWEEN

FACULTY OF TARBIYAH, UNIVERSITAS DARUSSALAM GONTOR, whose address is at Jl. Raya Siman Km 6, Ponorogo, East Java, 64371, Indonesia represented herein by its Dean Faculty of Tarbiyah Dr. Agus Budiman, M.Pd.

AND

WATANATHAM ISLAM SCHOOL, whose address is at 111 1, Pho Ming, Panare District, Pattani, 94130, Thailand represented herein by its Principal Watanatham Islam School, Ibarahim Abdullah;

hereinafter referred to singularly as “the Party” and collective as the “Parties”, wishing to establish relations between the two institutions, agree to cooperate with each other as follows:

Article 1
Objective

The parties, subject of the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies from the time in force in each Party's country, will endeavor to strengthen, promote and develop cooperation between the parties on the basic of equality and mutual benefit in the areas of common interests.

Article 2

General Areas of Co-operation

- (1) Cooperation shall be carried out through such activities as:
 - a. Education
 - b. Research
 - c. Community Service
- (2) terms of cooperation for each specific activity implemented under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity.

Article 3

Financial Arrangements

- (1) This Memorandum of Understanding will not give rise to any financial obligation by one party to the other, each party will bear its own cost and expenses in relation to this Memorandum of Understanding;
- (2) Upon embarking on any jointly and mutually agreed project and/or program, both Parties shall sign a Memorandum of Agreement (MoA) which stated, among others, the duration or time of the agreement and the financial obligation of individual and/or both Parties.

Article 4

Effect Of Memorandum

This memorandum of Understanding serves only as a record of the parties and does not constitute or create any obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

Article 5

Notice

Any such agreements entered into, as outlined above, will form appendices to this Memorandum of Understanding. Each institution shall designate a liaison officer to develop and coordinate the specific activities agree upon.

Article 6
Settlement of Disputes

Article 7
Renewal, Termination and Amendment

This Memorandum of Understanding shall remain in force for a period of five (5) years from the date of the last signature, with the understanding that it may be terminated by the appropriate authorities of either Party giving 1 (one) months written notice to the other Party, unless an earlier termination date is mutually agreed upon. The Memorandum of Understanding may be amended or extended by mutual written consent of the two Parties.
