Raya Siman Km. 6, Ponorogo, East Java, 64371, (hereinafter referred to as "UNIDA Gontor"),

Qinghai Hui (Islamic) Medical Research Association and Qinghai New Silk Road Hui Medicine Research Instituteand UNIDA Gontorshall hereinafter singularly referred to as "Party" and collectively be referred to as "the Parties".

WHEREAS

- e) Cooperation between the two parties, will promote occupational safety and health hospital management.
- f) Cooperation between the two parties, will promote dietetic and hospital food service management.
- g) Medium of instruction in all activities is English.
- h) Everything written in the contracts of both parties of 6.1 6.3 and the unspecified shall be made and subsequently considered by both parties.
