This Memorandum of Understanding (hereinafter referred to as MoU) is made on this **September 7, 2023,** located at **Universitas Darussalam Gontor, Indonesia**

BETWEEN

UNIVERSITAS DARUSSALAM GONTOR (hereinafter referred to as "**UNIDA Gontor**"), whose address is at Jl. Raya Siman Km. 6, Ponorogo, East Java, 64371, Indonesia represented herein by its Rector, Prof. Dr. Hamid Fahmy Zarkasyi, M.A.Ed., M.Phil.;

AND

THE ISTANBUL FOUNDATION FOR SCIENCE AND CULTURE (hereinafter referred to as "**İİKV**"), whose address is at kalenderhane Mah. Dedeefendi Cadç Cüce Çeşmesı Skç No: 6 34136, Vefa/Fatih Istanbul, Türkiye, represented herein by its Executive President, Said Yüce;

hereinafterreferred to singularly as "the Party" and collective as the "Parties", wishing to establish relations between the two institutions, agree to cooperate with each other as follows:

Article 1 Objective

The parties, subject of the terms of this MoU and the laws, rules, regulations and national policies from the time in force in each Party's country, will endeavor to strengthen, promote and develop cooperation between the parties on the basic of equality and mutual benefit in the areas of common interests.

Article 2 General Areas of Co-operation

- (1) Cooperation Shall be carried out throught such activities as:
 - a. Promote individual contact, link in teaching, research, and publication acivities among scholar, studemt and personnel of both institutions;
 - b. Holding Joint academic program;
 - c. Holding Joint research program, and publicatios;
 - d. Organizing conferences, seminars and academic meetings;
 - e. Exchanging information on research, literary sources and libarary facilities;
- (2) The terms of cooperation for each specific activity implemented under this MoU shall be mutually discussed and agreed upon in a separate writting by both parties prior to the initiation of that activity.

Article 3 Financial Arrangements

Upon emberking on any jointly and mutually agreed project and/or program, both parties shall sign a memorandum of agreement (MoA) which stated, among others, the duration or time the agreement and financial obligation of individual and/or both parties.

Article 4 Effect Of Memorandum

This Memorandum Of Understanding serves only as a record of the parties and does not constitute or create any obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute any legally binding or enforceable obligations, express or implied.

Article 5 Notice

Any such agreements entered into, as outlined above, will form appendices to this Memorandum of Understanding. Each institution shall designate a liaison officer to develop and coordinate the specific activities agree upon.

This Memorandum of Understanding shall remain in force for a period of live (5) years from the date of the last signature, with the understanding that it may be terminated by the appropriate authorities of either party giving 1 (one) monts written notice to the Memorandum of Understanding may be amended of extended by mutual written consent of the two parties.
