**MEMORANDUM OF UNDERSTANDING (MoU) FOR ACADEMIC  
EXCHANGES AND COOPERATION**

**BETWEEN**

**DARUSSALAM INSTITUTE OF ISLAMIC STUDIES, GONTOR, INDONESIA**

**AND**

**UNIVERSITI INDUSTRI SELANGOR, MALAYSIA**

**DARUSSALAM INSTITUTE OF ISLAMIC STUDIES, GONTOR, INDONESIA** and **UNIVERSITI INDUSTRI SELANGOR, MALAYSIA** hereinafter referred to as "the two Universities", fully recognizing that academic exchanges and cooperation between the two Universities would be beneficial to all concerned, hereby affirm their intention to encourage such academic exchanges and cooperation.

As a general declaration of intent, the two Universities agree to act as follows:

1. The two Universities will encourage the following activities:
  - i. Exchange of professors and researchers;
  - ii. Exchange of students;
  - iii. Collaborative research and joint academic meetings;
  - iv. Exchange of information, publications and materials for academic purposes; and
  - v. Other activities mutually as may be agreed by the two Institutes
2. The aforementioned activities shall be realized by means of consultation and exchange of relevant information by appropriate members of the two Universities, and may require the execution of additional agreements between the two Universities.
3. The cost and expenses incurred in performing any activity pursuant to this MoU will be negotiated to mutual acceptance between the two Universities.
4. This MoU may be amended by mutual written agreement.



5. This MoU is made in English.
6. This MoU shall become effective immediately upon being signed by the official representatives of two Universities and shall remain valid for a period of five (5) years.
7. This MoU may be terminated by either University with written notice six (6) months in advance. This MoU may be renewed for a further period of five (5) years by mutual written consent prior to date of expiration.
