



MEMORANDUM OF UNDERSTANDING
between
UNIVERSITY OF DARUSSALAM GONTOR (INDONESIA)
and
SCHOOL FOR INTERNATIONAL TRAINING
(THE UNITED STATES OF AMERICA)

In the name of God, University of Darussalam Gontor (UNIDA Gontor), and School for International Training (the accredited higher education institution of World Learning in The United States of America), wishing to establish relations between the two institutions, agree to cooperate with each other as follows.

Scope of the Cooperation

Subject to mutual consent, the areas of cooperation will include any program offered at either institution as thought desirable and feasible by either party and that all parties think will contribute to the fostering and development of the cooperative relationship between the two institutions.

Cooperation shall be carried out through such activities as:

- a. Exchange of faculty members and/or students
- b. Joint research activities and publications
- c. Participation in seminars and academic meetings
- d. Exchange of academic materials and other information
- e. Special short-term language and academic programs

The terms of cooperation for each specific activity implemented under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity.

Any such agreements entered into, as outlined above, will form appendices to this Memorandum of Understanding. Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed-upon.


Notification of any change in liaison officers may be made by letter without amending this *Memorandum of Understanding*.


