



MEMORANDUM OF UNDERSTANDING

In the name of God, University of Darussalam (UNIDA) Gontor, Indonesia, and Australia Indonesia Connections, Australia, wishing to establish relations between the two institutions, agree to cooperate with each other as follows.

Scope of the Cooperation

Subject to mutual consent, the areas of cooperation will include any program offered at either institution as proposed desirable and feasible by either party and that all parties think will contribute to the fostering and development of the cooperative relationship between the two institutions.

Cooperation shall be carried out through such activities as:

- a. Exchange of cultural programs
- b. Joint intellectual discourses programs
- c. Participation in dialogues on religions and thought
- d. Reciprocal program on language and other field of educational purposes

The terms of cooperation for each specific activity implemented under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity.

Any such agreements entered, as outlined above, will form appendices to this Memorandum of Understanding. Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon.
