## MEMORANDUM OF UNDERSTANDING

---

THIS MEMORANDUM OF UNDERSTANDING (“MOU”) is made on 09/11/2021

### BETWEEN

**ISTANBUL SABAHATTIN ZAIM UNIVERSITY**, a higher education institution incorporated in Turkey under the Council of Higher Education (CoHE) of the Republic of Turkey and having its main campus in Halkalı Cad. Halkalı - Küçükçekmece / Istanbul, Turkey (hereinafter referred to as “**IZU**”) and shall include its lawful representatives and permitted assigns, of the other part.

### AND

**UNIVERSITY OF DARUSSALAM GONTOR** which is a waqf college under the auspices of Pondok Modern Darussalam Gontor. Therefore, in carrying out its Tri Dharma, UNIDA Gontor maintains the vision, mission, and spirit of the pesantren (IZU and UNIDA are hereinafter referred to individually as “**Party**” and collectively referred to as “**Parties**”) Whereas the two parties desire to explore cooperation in various fields, the two parties conclude this Memorandum of Understanding (MoU) and agree to the following:

**Article 1** – To develop the following collaborative activities in areas of mutual interest:

1. Cooperation on training faculty staff. Particularly, IZU shall provide assistance for those who are interested in studying at IZU graduate degree programs.
2. Parties will act on a mutual understanding to assist students and academic staff who would like to participate in academic programs at the other party. Parties shall offer assistance on visa processes, accommodation and other administrative processes.
3. Conducting collaborative research projects.
4. Jointly organize symposia, seminars, conferences and explore possibilities of participation in each other’s events.
5. Exchange of academic information and materials.



**Article 2** – The development and implementation of specific activities based on this MoU will be separately negotiated and agreed between the faculties, or institutes, which carry out the specific projects. Both parties agree to carry out these activities in accordance with the laws and regulations of both countries.

**Article 3** – It is understood that the implementation of any types of cooperation stated in article 1 shall depend upon the availability of resources and financial support at both parties.

**Article 4** – Should any collaborative research activities under this MoU result in any potential for intellectual property, both parties shall seek a fair understanding as to ownership and other property interests that may arise.

**Article 5** – This MoU may be amended or modified by written agreements signed by the representatives of both parties and will become part of this MoU.

**Article 6** – This MoU is valid for a period of four years commencing on the date signed by the last party and may be renewed after being reviewed and renegotiated by both parties.

**Article 7** – This MoU may, at any time during its period of validity, be terminated by one of the parties upon written notice to the other party not later than six months before the termination date. The termination will not affect ongoing activities.

**Article 8** – Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiations between the parties, without reference to any third party or international tribunal.

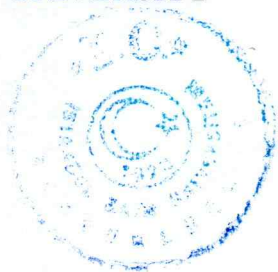
