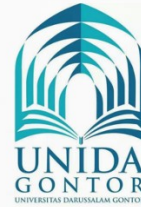




AGREEMENT
between
International University of Kyrgyzstan



and
University of Darussalam Gontor

International University of Kyrgyzstan and University of Darussalam Gontor (hereinafter referred to as "Parties") have signed the present agreement on academic cooperation.

Parties believe that they can promote their objectives by encouraging the development of collaborative and mutually beneficial relations.

Both Parties shall cooperate in the following areas:

- Mutual cooperation in academic staff mobility in order to support educational activities on Professional/ Bachelor's Degree / Master's Degree / Doctorate's Degree programmes,
- Mutual cooperation in mobility of academicians and students in undergraduate, graduate and post graduate studies,
- Mutual exchange of scientific information, publications which are educational and research purposes and other materials about education,
- Mutual cooperation in organising scientific conferences, panels, seminars, symposiums and workshops in order to reinforce the students' education and ensure the efforts regarding solidarity, cooperation and partnership by helping the students find and support their training places.
- Mutual cooperation in making proposals and working on joint scientific research projects and pilot projects,
- Mutual implementation of double degree programmes for Bachelor's students, Master's degree students and PhD students.
- The topics and areas, not mentioned in the framework of the agreement but may be needed in the future, will be taken into consideration after being in a mutual consensus or accordance with the article 8th placed in the protocol.

The agreement shall become effective upon the date of its signing by the Parties. The agreement shall be effective for the period of three years and upon mutual consent of both Parties, shall be automatically extended for another three years.

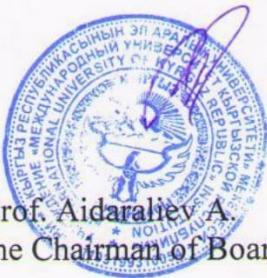
This agreement may be terminated early by the written notification by either of the Parties.

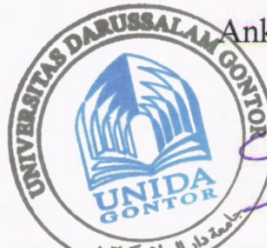
