#### **Article 5**

##### **Addendum**

1. Any additions/changes to this agreement may only be made with the written consent of **THE PARTIES**.
2. If one of the Parties wishes for any addition/change in this agreement, then **THE PARTIES** concerned shall notify the other Party with written documents first.
3. The additions/changes referred to in number (1) of this Article after agreed by **THE PARTIES** shall be outlined in an Addendum which becomes an inseparable part of this agreement.
