- 1. This activity costs IDR. 29.795.000 for internal funds, IDR. 20.000.000 for the partners, and all total IDR. 49.795.000 (forty-nine million seven hundred ninety-five thousand).
- 2. The budget mapping of this activity which is further charged to the parties includes the following:
 - a. Responsibility of resource persons costs (exempt or without intensive).
 - b. Incentives for article reviewers in the selected paper stage are charged to both PARTIES

Article 5 Addendum

1. Any additions/changes to this Agreement may only be made with the written consent of **THE PARTIES**.

- 2. If one of the Parties wishes for any addition/change in this Agreement, then THE PARTIES concerned shall notify the other Party with written documents first.
- 3. The additions/changes referred to in number (1) of this article after agreed by THE PARTIES shall be outlined in a supplement which becomes an inseparable part of this Agreement.
